One of my clients informed me that my corporation had been subjected to your administrative dissolution for not being in receipt of annual reports since 1999 and associated annual fees. Ironically, ignorance is not always a state of bliss. I, unfortunately, did not realize that an annual report was required and did not receive any notification from your office to that effect due to my having experienced a serious injury which necessitated a long recuperative period along with changing the business address from Tampa to Seminole without notifying your office. Also, evidently the US Postal service did not deem it necessary to forward any mail you might have transmitted to the Seminole address, which resulted in not receiving any communications from your office. However, each year there has been a proper tax filing for the firm's activities.
