

ARTICLES OF INCORPORATION OF



UNIVERSITY SCIENCE CENTER, INC.

The undersigned, being a natural person of legal age, does hereby desire to form a corporation under the laws of the State of Florida and does hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of this corporation shall be **UNIVERSITY SCIENCE CENTER**, **INC.** The mailing address of the corporation is 2200 Lucien Way, Suite 333, Maitland, Florida 32751.

ARTICLE II

GENERAL NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is:

To engage in the business of planning, developing, constructing, owning, operating and managing office buildings of all types and kinds and in conjunction therewith to do all things necessary or required to accomplish said purpose.


