ARTICLES OF INCORPORATION
OF

STORYLINE ACQUISITION CORPORATION

The undersigned, being a natural person of legal age, does hereby desire to form a corporation under the laws of the State of Florida and does hereby adopt the following Articles of Incorporation.

ARTICLE I

NAME

The name of the Corporation shall be STORYLINE ACQUISITION CORPORATION and the business address and location of the Corporation shall be 719 Peachtree Road, Orlando, Florida 32804.

ARTICLE II

CORPORATE DURATION

This Corporation shall commence to exist upon the execution of these Articles of Incorporation. The duration of the Corporation is perpetual.

ARTICLE III

GENERAL PURPOSE OF CORPORATION

The general purpose for which the Corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Florida General Corporation Act and to do all and everything necessary, suitable, or proper for the accomplishment of that purpose, the attainment of any objectives, or the exercise of any authority therein set forth, either alone or in conjunction with any other corporation, firm,

The aggregate number of shares for which the Corporation is authorized to issue is TEN THOUSAND (10,000). Such shares shall be of a single class, and shall have a par value of ONE and 00/100 DOLLAR (\$1.00) per share.


