ARTICLES OF INCORPORATION OF 19th Street Furniture, Inc.

The undersigned incorporator hereby forms a corporation under Chapter 607 g the laws of the State of Florida.

ARTICLE I

CORPORATE NAME The name of this Corporation shall be: 19th Street Furniture, Inc.



ARTICLE II

NATURE OF CORPORATE BUSINESS
