The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation for profit, under the laws of State of Florida.

ARTICLE I.

The name of this Corporation is THE THERAPY PLACE, INC.

ARTICLE II. NATURE OF BUSINESS.

The general character, purpose, and nature of the business to be transacted by this Corporation is any lawful business in the State of Florida, including operation of neuromuscular therapy.

ARTICLE III. CAPITAL STOCK.

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any time is 100 shares of common stock at a par value of \$10.00 per share.

ARTICLE IV. TERM OF EXISTENCE.

This Corporation shall have perpetual existence.

ARTICLE V. INITIAL PRINCIPAL OFFICE ADDRESS.

The initial street address and mailing address of the principal office of this Corporation is to be a 2301 Park Avenue, Suite 205, Orange Park, Florida, 32073.

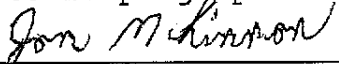
ARTICLE VI. RESIDENT AGENT/REGISTERED OFFICE.

That THE THERAPY PLACE, INC., desiring to organize under the law of the State of Florida with its registered office at 2301 Park Avenue, Suite 205, Orange Park, Florida, 32073, has named Jon McKinnon as its agent to accept service of process within the State.

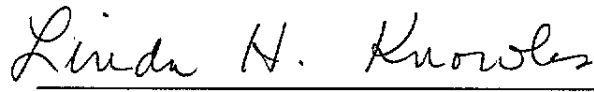

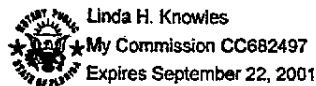
