The undersigned, for the purpose of forming a Corporation under the Florida Business Corporations Act, does hereby adopt the following Articles of Incorporation.

Article I - Name

The name of this Corporation is WORLDWIDE TRANSFER DISTRIBUTORS, INC. The principal place of business of this Corporation shall be 9702 Cedar Street, Tampa, Florida, 33635, or such other place as may be designated by the Board of Directors.

Article II - Capital Stock

The Corporation shall have the authority to issue 10,000 shares of common stock.
