ARTICLES OF INCORPORATION OF FANNY TRANSPORT, INC.

The undersigned subscribers to these ARTICLES OF INCORPORATION is a natural person competent to contract and hereby form a corporation for profit under Chapter 607 of the Florida Statutes.

ARTICLE 1 - NAME

The name of the corporation is Fanny Transport, Inc.

ARTICLE 2 - PURPOSE OF CORPORATION

The corporation shall engage in any activity or business permitted under the laws of the UNITED STATES and the STATE OF FLORIDA.

ARTICLE 3 - PRINCIPAL OFFICE

The address of the principal office is 3012 SW 92 Ave. Miami, Florida 33165 and the mailing address is the same.

ARTICLE 4 - INCORPORATORS

The name and street address of the Incorporator is Jorge L. Bermudez, 3012 SW 92 Ave., Miami, Florida 33165.

ARTICLE 5 - BOARD OF DIRECTORS

The initial Board of Directors of the Corporation shall be Jorge L. Bermudez, President/Secretary whose address shall be the same as the principal office of the corporation.
