**ARTICLE I - NAME**

The name of this corporation is Computer Systems Integration, Inc.

**ARTICLE II - DURATION**

EFFECTIVE DATE

10/2/98

This corporation shall have perpetual existence commencing on October 2, 1998 at 12:00 A.M. after filing these Articles with the Department of State.

**ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any or all lawful business for which corporations may be incorporated under Chapter 607, Florida Statutes, as now exists or may be amended.

**ARTICLE IV - CAPITAL STOCK**

This corporation is authorized to issue 1000 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

**ARTICLE V - PREEMPTIVE RIGHTS**

This corporation shall have one Director constituting the Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaw, however, there shall never be less than one Director nor more than three. 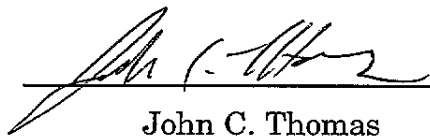
## **ARTICLE IX – INDEMNIFICATION**

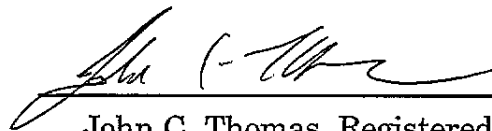
