ARTICLES OF INCORPORATION
OF

The undersigned, as incorporator of a Corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I - Name

The name of the Corporation is TREASURE COAST THERAPY SERVICES, INC. with its business address at 2101 S.E. Herron Avenue, Port St. Lucie, Florida 34952.

ARTICLE II - Duration

The duration of the Corporation shall be perpetual and the commencement of the Corporate existence shall begin at the time of the filing of these Articles by the Department of State.

ARTICLE III - Purpose

The Corporation shall be authorized to enter into contracts to provide staff personnel for therapy facilities and for consultation in the establishment of therapy providing institutions; and for engaging in all lawful businesses for which Corporations are authorized under the laws of the State of Florida.

ARTICLE IV - Capital Stock

The aggregate number of shares of stock of the Corporation shall be One Thousand (1,000) Shares of common capital voting stock, each having a par value of Ten and 00/100 Dollars for a total authorized capitalization of Ten Thousand and 00/100 Dollars (\$10,000.00).

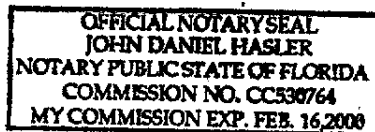
