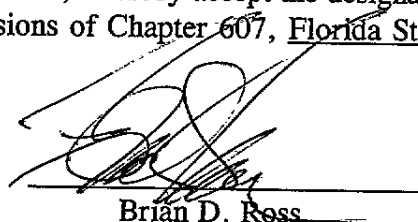
- FIRST: The name of this Corporation is J.B. Communications, Inc.
