

NAME

The name of this corporation is EXOTICA OF KEY WEST, INC.



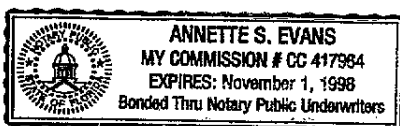
