**ARTICLE I
NAME**

The name of the Corporation is:

DURATION**

This Corporation shall have the perpetual existence commencing on the date of the filing of these Article of Incorporation with the Department of State of Florida.

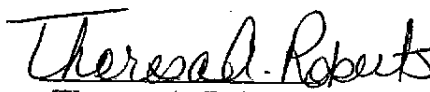
ARTICLE X
LIMITATION ON STOCKHOLDER SUITS

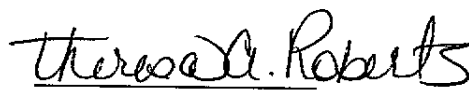

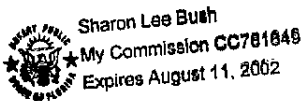
