## ARTICLES OF INCORPORATION OF CSCF, INC.

THE UNDERSIGNED, for the purpose of forming a corporation for profit pursuant to chapter 607, Florida Statutes, does hereby adopt the following Articles of Incorporation:

#### WITNESSETH:

ARTICLE I NAME

The name of the Corporation is:

CSCF, INC.

ARTICLE II DURATION

This Corporation shall have the perpetual existence commencing on the date of the filling of these Article of Incorporation with the Department of State of Florida.
