ARTICLE I

Name

ARTICLE VI


Initial Board of Directors


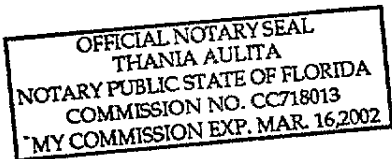
