ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of the corporation is R. D. Harner Corporation. (the "Corporation").

ARTICLE II - PURPOSE

The Corporation is organized to transact any and all lawful business for which corporations may be incorporated under the Florida Business Corporation Act.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock the Corporation shall have the authority to issue is Twenty-Five Thousand (25,000), all of which shall be Common Shares. The par value of each Common Share shall be One Dollar (\$1.00). All Common Shares shall be identical to each other in every respect, and the holders thereof shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.

ARTICLE IV - PRINCIPAL OFFICE

The street address of the principal office of the Corporation is 15096 96th Lane North, Palm Beach Gardens, Florida 33412.

ARTICLE V - INITIAL BOARD OF DIRECTORS

The Corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time by an amendment to the bylaws of the Corporation in the manner provided by law, but shall never be less than one.

The name and address of the initial director of the Corporation are Randall Harner, 15096 96th Lane North, Palm Beach Gardens, Florida 33412.


ARTICLE VI - INCORPORATOR


