## ARTICLES OF INCORPORATION OF Webb Consultant & CPA, P.A.

#### ARTICLE I -- NAME

The name of this corporation is Webb Consultant & CPA PAS AS ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.
