
ARTICLE VI



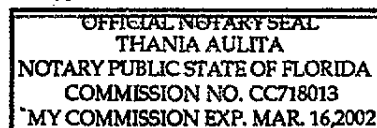


