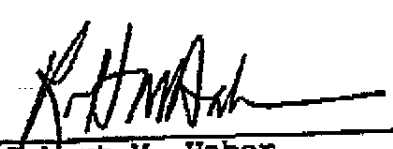
ARTICLE IX

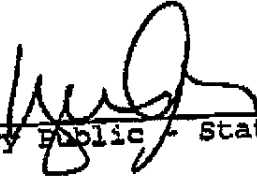

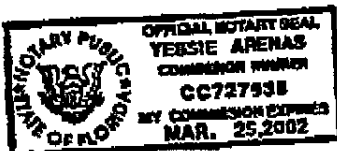

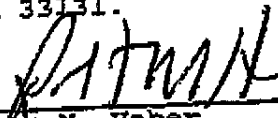
