The undersigned, acting as the Incorporator of a corporation under the Florida Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

**ARTICLE ONE**

The duration of the corporation is perpetual.

**ARTICLE THREE**

The purpose for which this corporation is to be formed is to establish and carry on business as permitted under the laws of the United States and Florida.


