#### ARTICLES OF INCORPORATION

### ARTICLE I. NAME AND ADDRESS

The name of the Corporation is SHIFTAN INVESTMENT CO., INC. ("Corporation"). The principal and mailing address of the Corporation is 150 Bradley Place, Unit 606-T, Palm Beach, Florida 33480.

### ARTICLE II. PURPOSES
