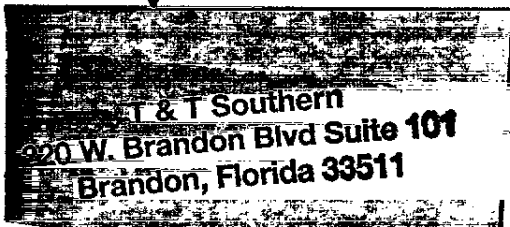

ARTICLE 1. The name of the Corporation is T & T SOUTHERN, INC.
