#### ARTICLES OF INCORPORATION

OF

#### GRAYCO AUTO WORLD, INC.

The undersigned incorporators, for the purpose of forming corporation under the Florida Business Corporation Act, which provides for the formation, rights, privileges, immunities, and liabilities of corporations for profit, hereby adopt the following Articles of Incorporation.

# ARTICLE I - NAME

The name of the corporation is GRAYCO AUTO WORLD, INC.

# ARTICLE II - DURATION

This corporation shall exist perpetually, commencing on the date of execution and acknowledgement of these Articles.

# ARTICLE III - PURPOSE

The corporation may engage in any activity or business under the laws of the United States and the State of Florida's General Corporation Act.

# ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 7,000 shares of \$1.00 par value common stock, which should be designated "Common Shares."

# ARTICLE V - CAPITAL

The amount of capital with which the corporation will begin business shall be \$100.00.
