ARTICLE I

NAME

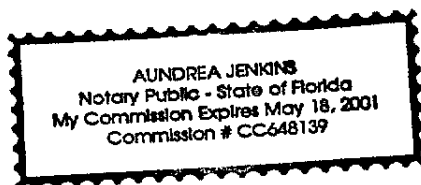
