

ARTICLES OF INCORPORATION



OF

ARTICLE 1: NAME AND MAILING ADDRESS

The name of this Corporation is TREKK F\X GRAFX, INC., and its principal office or mailing address is: 7101 - 34th Avenue North, St. Petersburg, Florida 33710.

ARTICLE 2: DURATION

This Corporation shall exist perpetually, commencing as of the date of acceptance and filing of these Articles by the Secretary of State of the State of Florida.

ARTICLE 3; PURPOSE

This Corporation is organized for the purpose of transacting any and all lawful business.
