# ARTICLES OF INCORPORATION

OF

# ISLANDBOY, INC.

I, THE UNDERSIGNED, IN ORDER TO FORM A CORPORATION FOR PROFIT, FOR THE PURPOSES HEREINAFTER STATED AND PURSUANT TO THESE ARTICLES OF INCORPORATION, STATES AS FOLLOWS:
