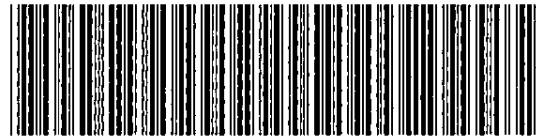

1. Article I of the Articles of Incorporation is hereby amended and the name of the corporation is hereby changed to be: "Victor Harding, M.D., P.A."

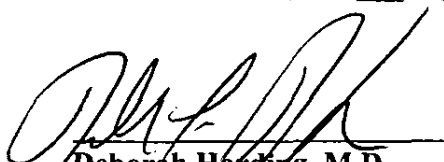
2. Article IV of the Articles of Incorporation is hereby amended to read as follows:
