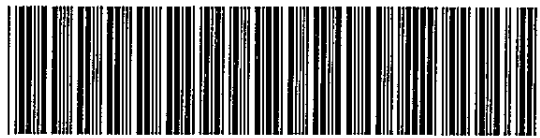



Pursuant to Section 607.1403 of the Florida Statutes, FSB Service Corporation, a Florida profit corporation, submits the following articles of dissolution:

First. The name of the corporation is FSB Service Corporation (the "Corporation").

Second. The Board of Directors of the Corporation adopted a resolution by unanimous written consent dated as of October 28, 2002 in lieu of a meeting of directors recommending to the Corporation's sole shareholder the advisability of the dissolution of the Corporation.


Third. The sole shareholder of the Corporation's common shares adopted a resolution by written consent dated as of November 9, 2002 in lieu of a meeting of shareholders approving the dissolution of the Corporation.
