ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Florida General

Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. The name of the corporation is **KOCH CONSTRUCTION, INC.**2. The address of the corporation is 5425 Shirley Street, #6, Naples, Florida 34109

4. The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and the State of Florida.

The period of its duration is perpetual.
