The undersigned incorporator, Bobbi Ann Phillips Roe, a natural person competent to contract, hereby presents these Articles of Incorporation for the formation of a corporation under the provisions of Chapter 607, Florida Statutes.

#### **ARTICLE I - NAME**

The name of this corporation is ROE ADVERTISING, INC.

#### **ARTICLE II - PRINCIPAL OFFICE**

The address of the principal office of the corporation is 518 Osceola Drive, Destin, Florida 32541.

### **ARTICLE III - PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business under the laws of the State of Florida and the laws of the United States.
