The undersigned, for the purpose of forming a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, do hereby adopt the following Articles of Incorporation:

- Article 1. Name. The name of the Corporation is: VANCE J. MALONEY III, M.D., P.A. The principal office of the Corporation is 650 N. Wymore Road, Suite 103, Winter Park, Florida 32789. The mailing address of the Corporation is 200 East Robinson Street, Suite 500, Orlando, Florida 32801.
- Article 2. Duration. The duration of the Corporation is perpetual.
- Article 3. Purpose. The general purposes for which the Corporation is organized are the following:
- A. To engage in and transact any lawful business for which a corporation may be incorporated to practice medicine under the Florida Professional Service and Limited Liability Company Act.
