Articles of Incorporation for the purpose of creating a corporation under the file the following Articles of Incorporation for the purpose of creating a corporation under the laws of the State of Florida.

The name of the corporation shall be: Aquatecture and More, Inc. ARTICLE I:

ARTICLE II: The corporation may engage in any and all lawful business permitted under the laws of the State of Florida.

ARTICLE III: The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows: fifty (50) shares Common Stock, no par value. All of said stock shall be payable in cash, property, real or personal, labor or services in lieu of cash, at a just valuation to be fixed by the Board of Directors of this corporation. ARTICLE IV: The amount of capital with which this corporation shall commence shall be not less than \$500.00.

This corporation shall commence its existence on the filing of this Certificate of ARTICLE V: Incorporation and shall exist perpetually thereafter unless sooner dissolved according to law.
