The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I - NAME AND PRINCIPAL OFFICE**

The name of this corporation is **THROWER & THROWER, INC.**, and its principal office is located at 221 N. Deerfoot Lane, Cantonment, Florida 32533.

**ARTICLE II - DURATION**

This corporation shall exist perpetually, commencing upon the date of filing these Articles of Incorporation with the State of Florida.

**ARTICLE III - PURPOSE**

The purpose of this corporation is to engage in any activity or business permitted under the laws of the United States or the State of Florida.

The name and the address of the incorporator is Vincent J. Whibbs, Jr., 421 N. Palafox Street, Pensacola, FL 32501.

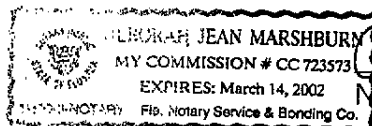
