ARTICLES OF INCORPORATION

OF

LOST TIME, INC.

MICHAEL TSERKEZIS, the undersigned, hereby associate, LOST TIME, INC., for the purpose of becoming a corporation for profit under the laws of the State of Florida, and do certify that LOST TIME, INC., has become such corporation under and pursuant to the following Articles of Incorporation.


