ARTICLES OF INCORPORATION OF





ARTICLE I

Name 1

The name of the corporation is CRYSTAL RIVER ALLIGATOR FARM, INC., and its principal business address is 1645 Palm Beach Lakes Boulevard, Suite #720, West Palm Beach, Florida 33401.

ARTICLE II

Duration

This corporation shall have perpetual existence.

ARTICLE III

<u>Purpose</u>

This corporation is organized for the transaction of any and all lawful business as allowed under the laws of the State of Florida with respect to corporations, as those laws now exist or as they may hereafter provide.

ARTICLE IV

Capital Stock

This corporation is authorized to issue 1,000 shares of ONE DOLLAR (\$1.00) par value common stock.

ARTICLE IX

Amendment

This corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, and any right conferred upon the shareholder(s) is subject to this reservation.

ARTICLE X

Bylaws

The bylaws may be adopted, altered, amended, or repealed by either the shareholders

or the Board of Directors, but the Board of Directors may not amend or repeal any bylaw adopted by shareholders if the shareholders specifically provide such bylaw is not subject to amendment or repeal by the directors.

Corporate existence shall begin upon the filing of these Articles of Incorporation.
