ARTICLES OF INCORPORATION

OF

ARTICLE I

The name of this corporation is: **SIERRA, INC.**

ARTICLE II

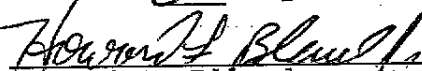
ARTICLE IX - BYLAWS
