ARTICLE ONE

The name of this corporation is BOCLAIR CORP. and the mailing address of the corporation shall be 3120 Metro Parkway, Fort Myers, FL 33916.

ARTICLE TWO

The date of the commencement of corporate existence of the corporation shall be the date these Articles are executed.

The duration of the corporation is perpetual.


