ARTICLES OF INCORPORATION  
OF  
PROGRESSIVE INDUSTRIAL DEVELOPMENT, INC.

In compliance with the requirements of Chapter 607, Fla.Stat., the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation is PROGRESSIVE INDUSTRIAL DEVELOPMENT, INC.

ARTICLE II

The street address of the initial principal office of the Corporation is 728 N.W. 8th Avenue, Gainesville, FL 32601. The initial mailing address of the corporation is Post Office Box 2218, Gainesville, FL 32602-2218.

ARTICLE III

The maximum number of shares this Corporation is authorized to issue is 100, all of which shall be Common Shares. 
