Pursuant to the provisions of section 607.1006, Florida Statutes, the undersigned Florida profit corporation hereby submits these Articles of Amendment for the purpose of amending its articles of incorporation:

1. The name of the corporation is AMERICAN AIRCARRIERS SUPPORT ACQUISITION III CORP.

2. The following amendment to the articles of incorporation of the corporation was adopted by its directors and shareholders on the 16th day of November, 1998, in the manner prescribed by law:

The name of the corporation shall be changed from
American Aircarriers Support Acquisition III Corp.
to AAS Landing Gear, Inc.

3. The number of shares of the corporation outstanding at the time of such adoption was 1,000; the number of votes entitled to be cast thereon was 1,000; and the number of votes indisputably represented by a written consent of shareholders was 0.

4. The number of votes cast for such amendment was 1,000; and the number of votes cast against such amendment was 0.
