EFFECTIVE BATE

The undersigned subscriber to these Articles of Incorporation, is a natural person competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the corporation shall be MICHAEL L. MARX INSURANCE AGENCY, INC.

ARTICLE II NATURE OF BUSINESS

This corporation may engage in **operating an insurance agency** and/or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation.

ARTICLE III CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 1000 shares of common stock having a par value of \$1.00 per share.

ARTICLE IV ADDRESS
