#### ARTICLE I

Corporate Name and Principal Office

EFFECTIVE DATE

The name of this corporation is DJD Investments, Inc. and its principal office and mailing address is 1726 East 7th Avenue, Suite 19, Tampa, Florida 33605.

#### General Nature of Business
