FOR

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation.

ARTICLE I

Name

The name of the corporation is **DHCH, INC.** The principal address is:

Duration

The duration of the corporation is perpetual.

Purpose

The general purposes for which the corporation is organized are the following:






