### ARTICLES OF INCORPORATION

OF

19TH HOLE BAR & GRILLE, INC.



### ARTICLE I - NAME:

The name of this corporation is: 19TH HOLE BAR & GRILLE, INC., hereinafter referred to as the "Corporation".

### ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing upon the filing of the Articles of Incorporation with the Department of State.

# ARTICLE III - PURPOSE:
