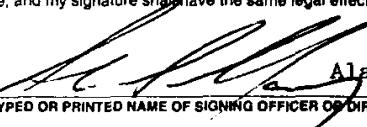

1. Alan A. Morey is the President of ASSET MANAGEMENT INTERNATIONAL, INC., a Florida corporation, (hereinafter "Corporation").

2. That the Corporation was administratively dissolved by the Florida Department of State on September 24, 1999.

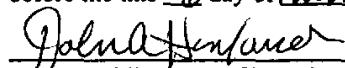
