ARTICLES OF INCORPORATION

ARTICLE I

EFFECTIVE DATE

The name of the corporation is: MENDOZA'S PASTA PRESTO, INC.

ARTICLE II

The effective date of this corporation shall be Oct. 1, 1998. The period of its duration is perpetual.
