**ARTICLE I. CORPORATE NAME**

The name of this corporation is: GATEWAY PROMOTIONS, INC., where the principal office is: 4815 E. Busch Blvd, #208G, Tampa, FL 33617.

**ARTICLE II. NATURE OF BUSINESS AND POWERS.**

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III. CAPITAL STOCK.**



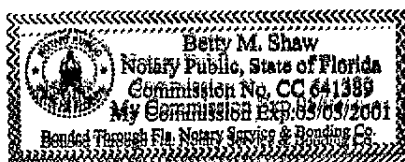


