The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, do hereby adopt the following articles of incorporation:

***Article One
Name***

The name of the corporation is Westerfield Enterprises, Inc.

***Article Two
Principal Office***

***Article Three
Corporate Duration***

The duration of the corporation is perpetual.

***Article Four
Purpose***

The purpose of the corporation is to buy, hold, manage, and sell real property within and outside the state of Florida.

The foregoing purpose and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any purposes which may become necessary, profitable or desirable for the furtherance of the corporate objective expressed above.

The aggregate number of shares which the corporation is authorized to issue is two hundred (200). Such shares shall be of one dollar (\$1.00) par value and of a single class only.

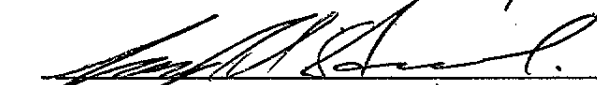

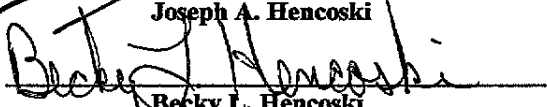

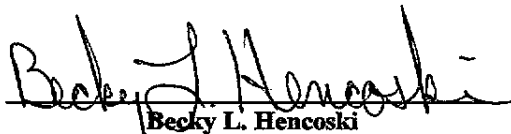
