**ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION
OF
MAR DON CORPORATION**

Pursuant to Section 607.1005, *Florida Statutes*, Mar Don Corporation ("Corporation") adopts the following Articles of Amendment to its Articles of Incorporation dated October 8, 1998.

ARTICLE I

Article I is hereby amended to read:

Article I - Name.

The name of the Corporation is **ULTRA KLEEN COIN LAUNDRY CORPORATION**. The principal place of business of the Corporation shall be 863 Violet Street, Tallahassee, Florida 32308. The name of the registered agent is Igler & Dougherty, P.A., 1501 Park Avenue East, Tallahassee, Florida 32301.


ARTICLE II


