We encourage you to utilize this procedure, as it will save you time.

To file the UBR online, go to the Division of Corporations "SUNBIZ" page located at www.sunbiz.org. Click on "Electronic Filing," then select the "UBR/Annual Report Filing." You will be prompted with questions, which you must answer to file the UBR. You may choose to deduct the UBR filing fee from a pre-established "SUNBIZ" E-Filing Account, or you may use a credit card (we accept most major credit cards).

In filing the UBR online, you must enter your business entity's Document Number, shown in Block 1 of the UBR; as well as the Electronic Access Code Number found in the lower right hand corner of this page.

If filed online, the UBR filing date will be the date that the UBR is correctly completed and transmitted to the Division of Corporations. If you choose to deduct the UBR filing fee from a pre-established E-Filing Account that has sufficient money on deposit to cover that filing fee, we will process the UBR immediately. If you choose to use a credit card, we will process the UBR within 24 hours of our verification of the credit card.
