The undersigned, natural person, who is licensed or otherwise legally authorized to practice the profession of Wholesale Sales in the State of Florida, hereby intends to form a Corporation under the Florida Statutes and hereby adopts the following Articles of Incorporation:

ARTICLE I

The Corporation is a Florida Professional Service Corporation organized under Florida Statutes Annotated. 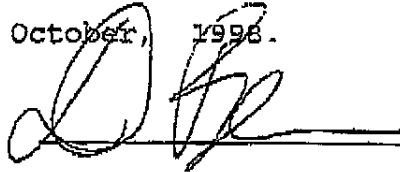

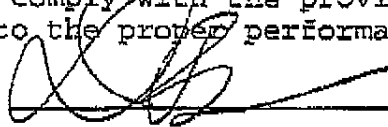
