**ARTICLES OF INCORPORATION
OF**

CABIN CREEK COUNTRY HOME PRIMITIVES, INC.

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation is **CABIN CREEK COUNTRY HOME PRIMITIVES, INC.**

ARTICLE II. DURATION

The corporation shall exist perpetually, commencing on the date of the filing of these Articles.

ARTICLE III. PRINCIPAL PLACE OF BUSINESS

The principal place of business for this corporation will be 910 McMullen Booth Road, Clearwater, Florida 33759.

ARTICLE IV. PURPOSE

This corporation is organized for the purpose of engaging in any activities or business permitted under the laws of the United States of America and of the State of Florida.

ARTICLE V. CAPITAL STOCK

This corporation is authorized to issue One Hundred (100) common shares of One Dollar (\$1.00) par value stock.

ARTICLE VI. PREEMPTIVE RIGHTS GRANTED

Every shareholder, upon the sale for cash by this corporation of any new capital stock of the same kind, class or series as that which he or she already holds, shall have the preemptive right to

purchase his or her prorata share thereof (as nearly as may be done without the issuance of fractional shares).

ARTICLE VII. REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE VIII. INITIAL BOARD OF DIRECTORS

This corporation shall have one (1) director initially. The number of directors may be either increased or decreased from time to time as provided in the Bylaws, but shall never be less than one (1). The name and address of the initial director of this corporation are:

ARTICLE XII. BYLAWS

The initial Bylaws shall be adopted by the Board of Directors. The power to alter, amend, or repeal the Bylaws or adopt new Bylaws is vested in the Board of Directors, subject to repeal or change by action of the Shareholders.


